The front desk computer is so fast now, it's very nice to have. *The reason it took a day and half is due to Pontem transferring the data to the new computer we had to have an appointment and Joey wanted everything up and running before the install.*

1. Wells Fargo: Sandra Wheeler has left Wells Fargo and will be attending this Board meeting to talk to the board about why and where she has moved to Stifel. *GM Sandi Miller reported that we are currently on our third representive at Wells Fargo since Sandra left. That Sandra told her on the phone that the people that have taken over her accounts do not have the knowledge for investing special districts funds. That she had learned this first hand when talking to them about funds the district has to be invested. Sandra Wheeler was then invited to speak to the board. She explained her reason for leaving, how she chose Stifel and what the could offer the district.*

2. **Ipad's:** Since the iPad's are too old to update to the programs, we need to use at the board meetings and are almost 8 years old. We can no longer use them for board meetings. We will need to decide what we are going to do with them. *GM Sandi Miller will check with our computer technician Joey to find out the value of the iPads considering their age. I will also check with the auditors to make sure they are fulling depreciated. Trustee Alan Langstraat suggested checking on putting them on a website for sale as well we might get more for them. GM Sandi Miller will check with Joey about which way to sell them.* 

- 3. Non-Resident Fees: At our last meeting we talked about reviewing the Non-Resident Fee. Please see attached fees charged by other districts and the description of a non-resident. GM Sandi Miller reported that she had looked at the fee report that CAPC put's out each year to give us an idea of what the other districts are charging. We are in the middle of what everyone is charging, but I think we need to consider the fact that we don't have as much available space as we used to. Per Health and Safety, the board must determine that we have plenty of space for our residents before allowing non-residents. Raising the fee might slow down the number of non-residents and help save land. After Discussion: the board decided to keep the non-resident fee the same for now.
- **4. Edger's:** We learned at the conference that we will need to handle the edger's different next year. They will be finished this year the end of October. GM Sandi Miller reported that *per AB5 signed September 11*, 2019, we can no longer classify our edger's as contract labor, due to the fact that they perform the same duties that the daily staff do. However, we can hire them as seasonal employees. And run their payroll through the office. We just need to approve it, decide to pay weekly or twice a month. I will need to speak to GSRMA our comp carrier to get the new rates. I will also need to check with CalPERS, they will be working more than allowed hours to not pay retirement on them.
- **5. Report on CAPC Conference:** Chairman Robert Allen, Vice-Chair Una Tristan and GM Sandi Miller will report on this. *Chairman Robert Allen reported that they always learn new things when they attend, and he found the Trustee breakout very informative. If at all possible, the rest of the board should try to attend a few. Vice-Chair Una Tristan was not at this meeting to report. GM Sandi Miller reported that as usual she ran the mic, although there wasn't much running to it this time. We only had 84 attendee's and 14 of them were new. New people tend to be afraid to ask questions. The next conference is in Oxnard February 20-22, this is the annual conference, awards and elections. Please let me know as soon as possible if you plan to attend the rooms sell out fast and its much easier and cheaper to stay where the conference is being held.*

- **Credit Card Machine:** It turns out I was making it harder than it needed to be, all I needed to do was change the screen and found out it was finished setting up. *Unlike the other credit card machine this one doesn't automatically send the batch in at night, we have to do it manually every night that it is used.*
- **Dump Truck:** I am still researching the truck trailer situation. I was hoping that I would see some equipment companies at the CSDA conference, but none sold dump trucks or dump trailers. Once I finish training Sarai I will have more time to give to researching which way is the best and most cost effective.
- **Letters to all applicants:** I sent letters to all the applicants right after the interviews.
- Items being moved around on grounds: On Monday 9/23 a family member came in saying that her items were on a grave 3 spaces down. This isn't the first time this has happened, and she marks her loved one's items inside so that you can't see them. Alvaro went down there and sure enough she was correct. Alvaro took pictures of where the items were on the grave and where they should have been. He then brought them to me, I have been trying to contact the family that removed the items from the grave they belonged on.
- **CSDA Conference:** This was a great conference; the classes were so good it was truly hard to decide which one to attend. I helped as I had signed up for and attended the required board meetings. The anniversary celebration was a lot of fun.
- **Email Law:** AB1184 was vetoed by the Governor on October 11, 2019. This law would require us to keep all emails, including junk emails for 2 years.
- **Transparency and SDA Renewal:** All the documentation and the application for renewal has been mail prior to the deadline. *Transparency renews every 2 years and my SDA every 4 years. There is now fee renewal.*

- **New office Assistant:** Sarai has translated all of our forms to Spanish and is doing a good job working with the families.
- **AB857:** On October 17<sup>th</sup> Governor Newsom, signed this bill into law. This allows Cities and Counties to establish public banking. What this means is that cities and counties can get together and open a bank for public agencies. This gives them the opportunity to barrow funds for project at a lower interest rate.
